



When you access the platform, you will start in this page. This is the main page for the TEODOR online platform:





Once you click on a microcapsule you will be redirected to a page that looks like the one below. Each microcapsule contains the ODP videos and the written theoretical content, as well as the evaluation part. After finishing each microcapsule participants have to pass the final test and submit their feedback in a form of assessment questionnaire.

## LEVEL II

When you choose to access the **Level II**, you will see all the different self-learning topics corresponding to organ donation. The first steps to do are privacy compliance and the pre-test. The results will be later compare with the final test. Each topic contains Theoretical content to read and self-assessment activity. To be able to access the next topic for the participant need to pass this activity on minimum 80%. After finishing all the topics participant needs to pass the Final Evaluation Test and submit the feedback.
